#### 1. INTRODUCTION

National Investment Trust Limited managing Mutual Funds has its Head Office in Karachi and business network in major cities of Pakistan.

#### 2. DETAILS OF SUPPLIES / SERVICES

NIT invites Suppliers / Vendors registered with tax authorities to submit bids in sealed envelopes for:

- i) Supply of Cloth for 108sets of Shirt / Pant and 06sets of Safari Suits.
- ii) Stitching of 66sets of Shirt / Pant and 06 sets of Safari Suits.

#### 3. TERMS & CONDITIONS

- i) Tenders will be submitted at NIT Head Office, NBP Building, 6<sup>th</sup> Floor, I.I. Chundrigar Road, Karachi up to 9<sup>th</sup> December, 2019 at 3:00 p.m.
- ii) Tenders will be opened at NIT Head Office on same date i.e. on December 09, 2019 at 3:30 p.m. in the presence of bidders and the same will be documented duly signed by the participants and members tender committee.
- Supply of cloth for **Winter Uniform** and stitching of uniforms will be made at NIT Head Office, Karachi as per approved samples meeting delivery timeline.
- iv) Rate (s) will be inclusive of all taxes, duties etc. levied by the Government of Pakistan.
- v) Quotation will remain valid up to 90 days from the date of its opening.
- vi) Tenders once opened by the Committee will not be taken back by the participants.
- vii) During tender process, any change in Government duties, taxes or change in price of fabric / stitching will be borne by the successful bidder.
- viii) Incomplete / conditional quotations will not be entertained.
- ix) In case of deviation from approved samples of cloth / stitching uniform will be returned with advice to submit the same meeting quality / colour / design as per approved samples within specified time to be notified to vendor. In case, vendor fails to supply uniforms meeting quality / design of approved samples, next vendor will be invited to supply the uniforms as per approved samples.
- x) Bidders will submit declaration that they are not blacklisted by Government / Semi Government Organizations for any deviation from procedure / supply of defected goods.
- xi) Vendors / suppliers will be eligible to offer bids for all supplies (cloth of uniform) and services (stitching of uniforms) and will be required to submit bids in sealed envelopes duly marked "Tender for Winter Uniforms Supply of Cloth and Stitching".

#### 4. QUALIFICATION OF BID

- i) Suppliers will submit copies of registration with tax authorities.
- ii) Suppliers blacklisted by Government / Semi Government organizations are not eligible to participate in tender process. Bidders not blacklisted will submit Declaration on Blacklisting by Government / Semi Government organizations to meet the requirement of eligibility on our Format (Attachment # 2).
- iii) Bidders will submit Bid Value inclusive taxes / all fees / all charges etc. on Bid of Quantity (BOQ) on our Format (**Attachment # 3**) for supply ofcloth and (**Attachment # 4**) for stitching of Uniforms with NIT Logo.

#### 5. EVALUATION OF BID

- i) The lowest evaluated bid will be accepted. The lowest evaluated bid does not refer to the lowest financial but the best bid in the interest of the institution.
- ii) Result of evaluation of bid will be communicated to all participating vendors.
