1. General Terms and Conditions:

- 1.1 Bid should be submitted in Pak Rupees only.
- 1.2 Bidder firm has not been black listed by any Government / Semi Government organization.
- 1.3 NIT reserves the right to accept/reject wholly or partially any tender at any stage of the tender process. Reason will be provided on request.
- 1.4 Validity period of the bids shall be made for at least 30 days.
- 1.5 The decision of NIT will be binding on all concerned and will in no case be challenged at any forum or any court of law.
- 1.6 Bids are liable to be rejected if; they are not confirming the terms, conditions and specifications stipulated in this tender.
- 1.7 During the examination, evaluation and comparison of the bids, NIT at its sole discretion may ask the bidder for clarifications of its bid. However, no change in the price or substance of the bid shall be sought, offered or permitted after bid submission.
- 1.8 The amount submitted as Earnest Money shall be refunded to the unsuccessful bidders after the decision for the award of said tender.
- 1.9 For this tender all updates/changes shall be communicated through email by NIT.
- 1.10 Availability of Laptop as Ex-Stock is required.
- 1.11 Bids submitted via email or fax will not be entertained.

2. Bid Submission:

- 2.1 Financial proposal should be marked 'Financial Proposal for Laptop' and contain bid price as per specification given in this document along with earnest money @ 2% of bid value.

3. Qualification Criteria:

- 3.1 The bidder should be registered with sales tax and income tax department
- 3.2 The bidder must be holding elite level partnership for Pakistan from the principal / manufacturer of the equipment.
- 3.3 Bidders who will not submit tender according to terms of tender will be regarded “Non – Responsive Bidder”
- 3.4 Bidders who will submit tender as per terms of tender will be classified as “Qualified Vendor.

4. Evaluation of Bid:

The lowest financial offer meeting or exceeding the required specifications will be the lowest evaluated bid.

5. Payment Terms:

- 4.1 Complete (100%) payment will be released after delivery and testing of the required equipment.
- 4.2 All payments shall be made after deduction of taxes.
- 4.3 Invoices shall be cleared as soon as possible not exceeding 20 days upon receiving the invoices.
- 4.4 All payments shall be made through cross cheque in the Pak Rupees.
- 4.5 Taxes will be deducted at source as per government rules at the time of payment.
- 4.6 Bidder should mention the installation and any other charges/optional charges in financial bid deemed necessary to complete the scope of work.
