## Objective of the fund

The objective of the NIT Islamic Income Fund is to generate a stable Shariah compliant income stream, while seeking maximum possible preservation of capital, over the medium to long-term period, by investing in a diversified portfolio of Shariah Compliant fixed income and money market instruments.

### Profile of Investment Managers

National Investment Trust Ltd. (NITL) is the first and the largest Asset Management Company of Pakistan, formed in 1962. With approximately Rs. 97 billion assets under management as on 31 October 2017, the family of Funds of NIT comprises of ten funds including 4 equity funds, 2 fixed income funds, 1 money market fund, 1 islamic income fund, 1 conventional pension fund and 1 islamic pension fund. NITs tally of nationwide branches is 23 and sales desk is also available in financial hub at Abbotabad, yet another milestone as no Asset Management Company in Pakistan has such a big network of branches. Further to cater to the matters relating to investments in NITL managed Funds and day to day inquiries/issues of their unit holders, a state of the art Investors' Facilitation Centre is also in place. The Board of Directors of NITL consists of representatives of leading financial institutions, prominent industrialists and a nominee of Govt. of Pakistan. The Company has been assigned an Asset Manager rating of "AM2+4" by PACRA, which reflects the company's high investment management industry standards and benchmarks with noted strengths in several of the rating factors. All Investment decisions are taken by the Investment Committee of the respective fund.

#### **Fund Performance Review**

The YTD return for FY18 stood at 4.18% p.a. against the benchmark return of 2.39% p.a. The Fund posted ar annualized return of 4.14% p.a for the month of October against its benchmark return of 2.51% p.a.

The Consumer Price Index (CPI) for the month of October remained stable at 3.80% versus 3.86% over the previous month. The FY18 average CPI inflation now stands at 3.50% compared to 3.95% during the previous fiscal year.


As at October 31, 2017, the Fund had an exposure of about 98% of total assets in cash at bank, about 2% in corporate sukuk and the remaining was in the form of other assets. The weighted average time to maturity of the portfolio stood at 25 days.


